- This [study](#) was conducted in March 2021. As at present, there is no additional information being provided to the unvaccinated as required by the Nuremberg code in order to arrive at informed consent. Failure to have informed consent constitutes a crime against humanity. Period.
- 2. The FDA did not approve [Moderna](#) or [Pfizer](#) mRNA gene therapeutics they dubbed "[vaccines](#)". It simply authorized them. [Fauci](#) confirms.
- From the newsdesk of MSN, [researchers report](#) that the Pfizer jab lowers your antibodies by a factor of 5-6. Their solution: Booster Shots.
- In 2012, the animal trials for mRNA jabs had to be [stopped](#) because the animals kept dying.
- The former President of the Association of American Physicians & Surgeons along with Molecular Biologist & Immunologist, Dolores Cahill, PhD, [confirm](#) animals died in previous mRNA animal studies.
- It's their word and reputations against that of anonymous, unaccountable 'fact checkers' paid to promote experimental mRNA jabs.
- But, even if there was concrete proof, the current studies with humans show a catastrophic failure bordering on genocide.
- As at July 9/21, seven months into the vaccination program, the number of vaccine deaths (9,025) from these experimental mRNA injections surpass the [combined number of vaccine deaths](#) for the past 30 years (4,924) by a factor of 1.8.
- In another month, more than twice as many people will have died from vaccines in 2021 than in the past 30 years combined. Let that sink in.
- Yet, they are being promoted as 'safe', and the FDA is expected to approve them.
- For those who cite successful Pfizer [animal studies](#), let's be very clear: These were not long term studies. At most, they lasted 8 weeks, and come with some very problematic conclusions:
 - a. "No viral replication was detectable in the nose of any of the eight animals in the 100- μ g dose group by day 2 after challenge"
- Yet, the vaccinated are not promised immunity from COVID-19 infection.
 - b. "Vaccination of nonhuman primates with mRNA-1273 induced robust SARS-CoV-2 neutralizing activity, rapid protection in the upper and lower airways, and no pathologic changes in the lung."
- Real world data with humans produce completely different conclusions.
 - c. "After SARS-CoV-2 infection, nonhuman primates have transient viral replication in the upper and lower airways and mild inflammation in the lung that resolves within 14 days. Thus, nonhuman primates are a useful animal model for assessing vaccine-mediated protection against early viral replication."
- This corroborates with Fauci's assertions of the therapeutic nature of these shots in decreasing the severity of the illness - not inhibiting infection or contamination.

- d. "In addition to the lung sections from these earlier time points, lung sections from animals that **were killed at day 14 or 15** after challenge had no evidence of substantial inflammation, and neither viral RNA nor viral antigen was detected in any of the groups, including the control group. Vaccine-associated immunopathologic changes were not observed in any of the sections examined."
- How many animals were killed? When in 2020 did the study take place?
- And what's suspect about this timeline?
- - On January 22-23/20, the WHO Director- General [convened](#) an Emergency Committee (EC) under the International Health Regulations (IHR 2005) to assess whether the outbreak constituted a public health emergency of international concern. The independent members from around the world could not reach a consensus based on the evidence available at the time. They asked to be reconvened within 10 days after receiving more information.
- - According to Pfizer, their "vaccine" was developed on January 25, 2020, in a few hours. The fastest time on record to develop a vaccine, up until then, was 4 years.
- All a bit strange?
- - Pfizer, that's listed on the stockmarket, issued a White House [press release](#) on March 2, 2020, stating: "We are happy to **volunteer** our expertise and resources to aid the development and delivery of possible solutions."
- As Biden announces Surge Teams to fight [Delta](#) variants in hotspots, Fauci fails to explain that the Delta variant (dubbed B.1.617.2) is produced by the [vaccinated](#). In other words, vaccinating the unvaccinated will only accelerate the spread of the Delta variant.
- Variants vary by only .3% from the original virus, according to former Pfizer VP, [Dr. Michael Yeadon](#), and are always [attenuated](#), or less virulent versions of the original version, that is, they are [less deadly](#). - AstraZeneca was dropped by 24 [countries](#), and by [Ontario](#) as of May 11/21. Johnson & Johnson, a [Viral Vector](#) "injection" that was given [Emergency Use Authorization](#) on Feb. 27/21, was halted by several states due to the [formation of blood clots](#).
- The [CDC](#) had confirmed. But distribution resumed after a [10 day pause](#).
- The CDC also confirms that Pfizer & Moderna jabs are the [deadliest](#) of all "vaccines", shown here in a [bar chart](#) and a [video](#) with step-by-step navigation of the VAERS site. The ingredient [SM-102](#) that is not recommended for human or veterinary use should bring the entire jab

campaign to a screeching halt, one would think.

- And, as of May 13/21, [fully vaccinated](#) people didn't need to wear [masks](#) in most places.
- What about the 99.9% who beat Covid? Why weren't they allowed to spread their antibodies? And in Australia, why are vaccinated people being asked to quarantine if they visited [infected areas](#)? Because these jabs don't act as vaccines that prevent infection or contamination.
- 4. The [clinical trials](#) will be completed in October 2022 for Moderna, and May 2023 for Pfizer. The 'vaccinated' are the guinea pigs.
- Troubling [information](#) for women on post-vaccination reproductive symptoms is emerging.
- More troubling is the fact that while the CDC admits scientists are still learning how well vaccines prevent you from [spreading the virus and how well they protect people](#), [Federal](#) and State Health agencies continue to label the vaccines as [safe](#) for pregnant or lactating women or those who are Covid-recovered. - "Female participants of non-childbearing potential may be enrolled in the study. Non-childbearing potential is defined as surgically sterile (history of bilateral tubal ligation, bilateral oophorectomy, hysterectomy) or postmenopausal (defined as amenorrhea for ≥ 12 consecutive months prior to Screening without an alternative medical cause). A follicle-stimulating hormone (FSH) level may be measured at the discretion of the Investigator to confirm postmenopausal status.
- Female participants of childbearing potential may be enrolled in the study if the participant fulfills all the following criteria:
 - - Has a negative pregnancy test at Screening and on the day of the first dose (Day 1).
 - - Has practiced adequate contraception or has abstained from all activities that could result in pregnancy for at least 28 days prior to the first dose (Day 1).
 - - Has agreed to continue adequate contraception through 3 months following the second dose on Day 29.
 - - Is not currently breastfeeding.
- And in its Exclusion Criteria:
 - - Is pregnant or breastfeeding.
- [Pfizer's clinical trial synopsis](#) under Exclusion Criteria:
 - - Women who are pregnant or breastfeeding.
- And yet, the [FAQ websites of all 50 States](#) still consider the Covid vaccines to be "safe" for the average person, and pregnant or breastfeeding women, while in Britain, as at June 2, 2021, 920 pregnant women lost their babies after getting ["vaccinated"](#)

- 5. Some will argue that SARS-CoV2 was developed in a [Gain-of-Function](#) lab, and will back their claims with [reports](#). Taiwan News even provides an interview as [proof](#)

- This badly scripted movie gets worse. As of June 30/21, there is a push to [vaccinate](#) in order to protect from the (attenuated) Delta variant, not the original more potent virus, while there is every indication from hospitalizations that the Covid-19 [movie](#) is soon coming to an end. They have run out of plots.
- And, [according](#) to Bill Gates' own [MSN](#) Lifestyle, the mRNA jab can alter your DNA. He quotes a [NCBI](#) article. Don't expect this article to ever be dignified by a peer review. It will never happen. This is all part of the Hidden in Plain Sight script. When [Moderna's chief scientist states](#) that mRNA jabs hack the software of life (DNA), there should be no further discussion.
- In the US, **over 183 million people** have been jabbed at least once, as of July 9/21, or 55.3% of the population.
- As already mentioned, the CDC has ceased [reporting on](#) the number of Covid-19 post-vaccination cases (breakthrough cases), as of May 1/21. The numbers are too embarrassing, The [last CDC number of reported breakthrough cases](#) stood at 9,245, resulting in 132 deaths, or a 1.4% death rate.

- Using that same 1.4% death rate, given that [the most recent number](#) of **Covid-19 post-vaccination deaths stands at 988** (as at July 9/21), and given Dr. Birx's very liberal [definition](#) of mortality, we can estimate the current number of **post-vaccination Covid-19 infections to be around 70,571**. That's a conservative estimate. A more liberal estimate would be 700,000.

- The CDC contravened Federal Regulations once more when it issued a [change](#) in it's reporting rules.
- From the CDC [website](#):
- "As of May 1/21, CDC transitioned from monitoring all reported vaccine breakthrough cases to focus on identifying and investigating only hospitalized or fatal cases due to any cause. This shift will help maximize the quality of the data collected on cases of greatest clinical and public health importance. Previous case counts, which were last updated on April 26/21, are available for reference only and will not be updated moving forward."
- In other words, we are to believe that suddenly the vaccinated are dying from natural causes and preconditions (not the vaccines or Covid, and that hardly anyone is injured by the "vaccines"), but the unvaccinated keep dying from Covid, while Israeli [data](#) shows 3,133 people contracted Covid from the vaccinated.

- On June 17/21, Fauci warned that the DELTA variant will cause more deaths in the [unvaccinated](#) while dismissing the fact that deaths by vaccines in 2021 have exceeded the combined number of vaccine deaths for the last 30 years.
- Biden pumps the same [fear](#). And, Rochelle Walensky joins the chorus to get teens [vaccinated](#), as she completely side steps the survival rate for that age group, but relies on spurious reports of increased hospital admissions. Here are UK's [2020-2021](#) hospital admission numbers.
- The fact is that [60,000 Americans](#) have been dying weekly, consistently, before and after the Covid scare - more [data](#) - while deaths by influenza and other diseases have plummeted.

- Deaths by influenza have [dropped](#) from 61,000 in 2017-2018 to 22,000 in 2019-2020, while [medical malpractice](#) is the third leading cause of deaths in the US.
- 13. [Hospitals are paid](#) \$13,000 for every Covid19 admission, and \$39,000 for every patient that is put on a ventilator, on average. [More proof](#) doctors and nurses [have orders](#) to place on ventilators patients who tested negative, effectively killing [88%](#) of them.

- A [primer](#) on PCR tests. A retraction [letter](#) by an international consortium of life-science scientists, admits PCR tests are flawed.
- Neither the CDC can provide samples of SARS-CoV-2, nor can [Stanford and Cornell labs](#), and in a [CNN interview](#) Fauci said he was not getting tested as there is no need to test asymptomatic people. He [reiterates](#) that asymptomatic people have never been the driving force of a pandemic. Again, the [WHO](#) backs him up.
